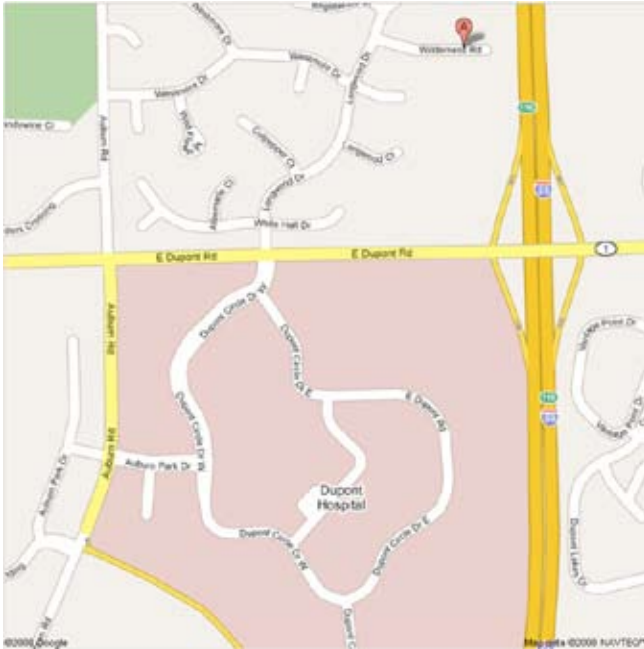

Be sure to come and see some "really neat old stuff". Thanks Terry, at the Van Wert Hamfest I got to see some of the tube gear that Terry has available and there are some really nice radios. There will be all that and more at this year's tailgate hamfest.

Before I run out of space I do want to let everyone know how we did at Field Day this year. Once I got the GOTA results, I found that we did even better than I reported at the July general meeting. Keep in mind that the data I have only goes back to 1999. When I went back through the data I

discovered some bonus points I missed earlier and we did end up setting a recent record number of bonus points after all.

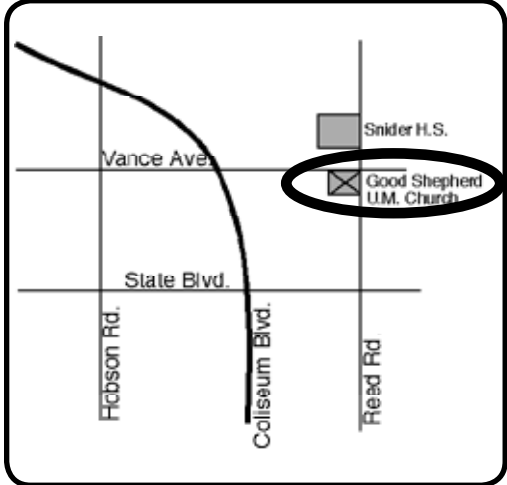
So, since my data started in 1999, we set records in the following categories this year: most 20 m Phone contacts at 668, most 10 m CW contacts at 12, most 40 m CW contacts at 616, most phone contacts at 1222, most CW contacts at 894, most total contacts at 2177, highest claimed score at 6264, highest bonus points claimed at 1310, and finally highest total score at 7574! A huge thanks to everyone that helped out at Field Day. And a special thanks to Chad, W9GGA, for the entertainment he provided after dinner on Saturday.

Also keep in mind that we have nominations for 2010 coming up in September and elections in October.

## Fort Wayne Radio Club Meeting Minutes 17 July 2009

The July Meeting of the Fort Wayne Radio Club was held at the Good Shepherd United Methodist Church on 17 July 2009 with club president Tom Baker serving as host. There were about 30 persons present.



### Old Business:

Tom Baker started the meeting by having all in attendance introduce themselves and their calls.

Al Burke read the June meeting minutes and there were no corrections.

Bob Streeter gave the Treasurer's report. As of 17 July 2009 the club had realized an income of \$1,869.46, expenses year-to-date of \$785.70, and had \$77.00 in cash plus \$7,590.37 in checking/savings. The repeater antenna replacement fund had collected \$438.06 in donations to date plus a pledge of \$100.00 from Art Kidd, WK9DD. In addition, Jim & Annie Pliett and Carole & Al Burke had pledged a total of \$400.00 towards replacement of the 146.910 MHz antenna at Robison Park.

Al Burke gave a report on the July foxhunt. The details are contained in the July edition of the Foxhunt Chronicles.

### New Business:

Joseph Lawrence, K9RFZ noted that there would be a RACES drill this coming Saturday, 18 July starting at 08:30 am. It would be a statewide drill with local business coordinated using the 146.94 MHz machine.

Larry Temenoff proudly showed-off a prime example of a Heathkit HW-20 "Pawnee" 2 meter radio that he acquired at the Lansing Antique Radio Association show. The 1960's era kit had been built by an 82 year old ham who spent about \$3000.00 in today's dollars for the kit back in the 60's and further invested about 80 man-hours to assemble it. Things sure have changed.

Tom Baker reported that the August club meeting will be the Tailgate Hamfest. It may be held in Phil Hooper's Ham Radio Store parking lot (out in New Haven), rather than in the church parking lot as has been the practice in the past. Stay tuned for the venue.

Tom noted that program opportunities for the September, October and November meetings are at present undetermined. Anyone with program suggestions, or offers to provide same, should contact Tom or any of the other club officers or Board members.

Tom Baker noted that, considering the antenna fund donations already in the treasury plus the pledges received from Art Kidd and from the Pliett's / Burke's for the 146.910 machine's antenna, the fund is up to about \$1,880 considering the match to be provided by the club treasury. Tom discussed several possibilities that are on the table:

1. Don't replace the Robison Park 146.910 MHz antenna, i.e., don't put 146.910 back on the air.
2. Replace the Robison Park 146.910 MHz antenna and put it into service with ACARTS' APRS system and move the 146.910 MHz machine to the IPFW ATV site.
3. Replace the Robison Park 146.910 MHz antenna and put the 146.910 MHz machine back in service at Robison Park and install the ACARTS APRS system at the IPFW ATV site

There was considerable discussion relative to the alternatives presented and Tom asked for a show of hands in regards options 2 and 3 (above). The show of hands seemed to indicate a preference for option 2.

Art Kidd indicated that the One Summit Square building superintendent, a ham, had indicated to him that there might be the possibility of locating a repeater at that site utilizing an elevator tower to mount the antenna, and an elevator room to house the equipment. This is certainly worth exploring with AEP, and the Board of Directors intends to pursue this possibility.

Following the business meeting Tom Baker discussed this years Field Day activity. Some very initial comments received regarding the pros and cons of using the IPFW site versus the Girl Scout Camp site were:

### IPFW

Location too noisy  
Stations too spread out  
Dining provisions (as provided this year highly susceptible to weather)

### Girl Scout Camp

Location too noisy  
Stations too close together  
Dining provisions great

Overall, the Field Day activities seemed to run smoothly, including set-up and tear-down. The logging software worked superbly and should be of great benefit in analyzing various aspects of station performance. Tom noted that our total points accumulated this year (operating 7A) were 7,308 versus 4,854 points last year (operating 5A). And he said that our claimed score this year was 6,148 versus a claimed score last year of 3,944.

## Stuart's First QSO – By Dan Romanchik, KB6NU

One of the great things about Field Day are the stories. Every year, I add a story or two to my repertoire. This year is no exception.

My best story from Field Day 2009 starts about 1:30 p.m. on Saturday. I was at my post at the public information table/GOTA station. We had been ready to rock and roll for at least a half hour, so a group of us were just sitting around chewing the fat when 13-year-old Stuart and his mother walked up to the table.

Her son was a little on the shy side, so his mother explained that Stuart had seen a listing of our Field Day site on the Internet and had asked her to bring him out to see us. She mentioned that Stuart had been listening to ham radio operators on his little Yaesu handheld scanner for several years and was very excited to actually meet some ham radio operators and see ham radio in action.

Not only that, she said that he had taught himself Morse Code. A kid after my own heart! I quickly volunteered to give them a tour of our Field Day site. First, I showed him our VHF/UHF station, and he seemed really impressed with the five single-band radios.

Next, I took him into the 40 m phone station. I asked how fast he could copy Morse Code, and he said 30 words per minute. I cranked the receiver down into the CW portion of the band, and sure enough, he could copy anything that I tuned in.

At this point, it was still only 1:45 p.m., so I told him, "Let's go over to one of the CW stations, and we'll see if we can make a contact." We marched over to the CW #2 station, and after getting clearance from the station captain, I tuned around for a clear frequency, then called CQ. Immediately, N5VV, replied.

At this point, Stuart was so excited, he was shaking a little bit. Since the contest was just about ready to start, I kept the contact short, but that didn't matter. Stuart had finally gotten to see ham radio in action.

Stuart's mother then inquired about taking the test. I explained that our Volunteer Examiners give the test every second Saturday of the month and gave her the URL of our website. She said that Stuart had been studying and was ready to take the test.

Unfortunately, they had to leave at that point. I told Stuart's mother that we'd be there through 2 p.m. Sunday and to come back any time. She said that they'd definitely be back the next day.

### Stuart Makes His First Contact

Stuart and his mother returned about 1:30 p.m. on Sunday. He wanted to see the VHF/UHF station again, so that was our first stop. He took a couple of photos of the setup, and then I suggested we go over to the GOTA station. When we first got there, someone was at the mike, but shortly afterwards, they got up, and Stuart and I took the controls.

When we first sat down, I made a few contacts using my call to show him how to use the paddle. I noted that holding the levers down produces a series of dits or dahs, and that by tapping the other lever while holding down the first, you can produce a dit between dahs or a dah between dits.

**Now, remember, this is someone who'd never touched a paddle of any kind before.**

Then, I asked him if he'd like to try it. He said yes, so just to see how it would go, I tuned up to above 7100 kHz. There was no activity up there, so I set the keyer speed to 15 wpm and told him to send my callsign a few times. He reached over with his left hand and sent it perfectly. Now, remember, this is someone who'd never touched a paddle

of any kind before. Not only that, he even sent the K (dah-di-dah) iambically! That is to say that he held the dah paddle while tapping the dit paddle to slip in a dit between the two dahs.

Then, I asked if he'd like to make some contacts. He said yes, so I said, "Let's switch seats." We switched seats, and I said, "OK, tune around a little and find a strong station calling CQ." We found K2ZR, and I coached him a little on how to reply. "Now, remember," I said, "we're going to use the W8PGW callsign." When I gave him the nod to send, he reached over with his RIGHT hand and sent W8PGW perfectly! When K2ZR replied with our call and the exchange, I coached him to reply with "4A MI." Not only did he do that, but he slipped in a "R" to denote that we'd copied the exchange. When K2ZR replied with a "TU," I showed him how to log the contact.

That's all the coaching I needed to do. After the first contact, I said, "OK. Now, tune around for another station calling CQ, and we'll make another contact."

## Logging Programs and Keeping Track of Your QSLs – Gary Stebbins, KC9GGV

Logging software programs - What's FREE - what's not. Do you really need a \$150 software package for logging? Since the beginning of amateur radio the most important part of the hobby has been maintaining a log of your contacts. Your log is important especially if you are trying to obtain a specific award, such as the ARRL Worked All States (WAS) Award or the ARRL DX Century Club (DXCC) Award for working 100 countries (more properly called entities) or any of the other fine awards that are available.

Before logging by computer became popular, keeping track of your QSOs/QSLs required maintaining a manual paper logbook and a checklist for the award you were working towards, and keeping track of all your QSL cards.

With a computer logging program you will be able to track every contact you make by date, time, band, mode and frequency as simply as typing in the call sign of the station you are working. If your computer has access to the internet and you have an interface cable attached to your radio (if your radio supports a computer interface) the other station's information (name, address, state, country) will be automatically retrieved from one of the call sign servers on the internet (i.e. Hamcall or QRZ.com). If you are operating without internet access (Field Day, portable, etc.) you can use one of the call sign database CDROMs available from Hamcall, Flying Horse or QRZ.com. If your radio is a vintage rig that does not have a computer interface, you may still log by computer but you will need to enter the call, band, mode and frequency. The computer will retrieve the rest of the other station's information.

There are several logging packages available to the radio amateur. Some are FREE and some are not. Some of the commercial (\$\$\$\$) logging programs are LOGic 8! (www.hosenose.com), Mac Logger DX (www.dogparksoftware.com) and ProLog2k (www.prolog2k.com). These are just a few of the most popular. All of the commercial programs do an excellent job of maintaining your log and have very useful features. The prices range from \$60 to \$130 depending on the features and options at the time of purchase. If you own a Macintosh computer, your best solution will probably be MacLoggerDX which costs about \$95.

But if you are a PC owner, you have lots of good FREE

logging solutions to choose from. My personal favorite is DXKeeper by Dave Bernstein, AA6YQ (www.dxlabsuite.com). The DXKeeper logging program is a part of a suite of amateur radio related programs that operate together.

DXKeeper is a FREE and comprehensive amateur logging software that

- records and manages QSOs
- extracts name, address, and location information from Callbook CDROMs (Flying Horse, HamCall, QRZ) or QRZ.com (with a subscription, or without a subscription using Pathfinder)
- Tracks progress towards DXing awards (DXCC, Challenge, VUCC, TopList, Marathon, WAS, WAC, WAZ, WPX, IOTA, Counties, Maidenhead Fields, Maidenhead Squares)
- Independently tracks hardcopy QSL, eQSL.cc, and Logbook of the World (LotW) confirmations for each QSO
- Prints QSL cards and QSL Labels, addresses envelopes, and prints address labels
- Uploads QSOs to eQSL.cc and LotW
- Downloads QSLs from eQSL.cc and LotW, and automatically updates your log to reflect confirmations
- Identifies QSLs required for DXCC submission, and generates required documentation
- Tracks DXCC verifications
- Imports and exports ADIF-compliant log files.
- Interoperates with Commander, DXView, SpotCollector, and WinWarbler
- Logs QSOs in real-time from MultiPSK, MMVARI, MMSSTV, MMTTY, and MixW

One of my favorite features in DXKeeper is the upload capability of electronic QSLs for the ARRL Logbook of the World (LotW). You will need to install the ARRL TQSL software in addition to DXKeeper on your PC. But you will only have to set your username and password information in DXKeeper during the initial setup process. From then on uploading QSOs to LotW will

He was off to the races. As soon as he made a contact, he jumped up to type it into the log. His arms weren't long enough to reach the computer from where he was seated.

When we started, the keyer speed was set to 15 wpm. After a couple of contacts, I asked if he might want to send faster. When he said OK, I bumped it up to 18 wpm. After a few QSOs with only a couple of mistakes, he asked if we could go faster, so I set it at 20 wpm. Again, only a couple of mistakes, so we bumped it up to 22 wpm. There, he started making more mistakes, but let me repeat, he never touched any kind of key before in his life. I have no doubt that with a little practice, he could easily do 30 wpm.

Overall, he made 12 contacts in the 21 minutes he operated the station. Not a bad rate for someone who'd never sent a character of Morse Code in his life, don't you think?

Unfortunately, Stuart was not able to take the test at our July VE session as he was at Boy Scout camp. Come the second week of August, though, he'll be a ham. He even has a vanity callsign picked out for himself. Listen for him--in the CW bands, of course.

only require a few mouse clicks. If you are an eQSL.cc user you may automate uploads to that site, also. DXKeeper will also track your paper QSL cards.

If you are going to install DXKeeper on your PC, I would suggest following the instructions on the DXLab web site ([www.dxlabsuite.com](http://www.dxlabsuite.com)). I strongly suggest that you install the DXLab Launcher program first. This will also track when updates are available for the installed programs from the DX Lab Suite. Then install DXKeeper using the DXLab Launcher. Dave provides complete instructions on the web site. All of the programs in the suite are intended to work together. These are some very powerful tools for the radio amateur and they are all FREE. You only need to install the ones you want to use. If you have a computer interface cable for your radio you will want to install Commander or you

can use Ham Radio Deluxe as an alternative control program for your radio. There are instructions for setting up and integrating some of the other excellent FREE and shareware programs available for amateur radio use using special DDE or bridge programs. See the DX Lab site for all the details on other programs that can be integrated.

I have been using DXKeeper for almost four years now and in my opinion it is a "keeper".

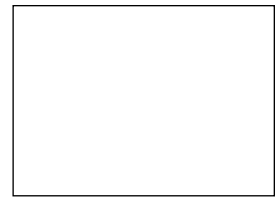
