Also we have groups.io/g/lrbn, but you will need to sign up. This is where we vote for the next lunch. Let me know if

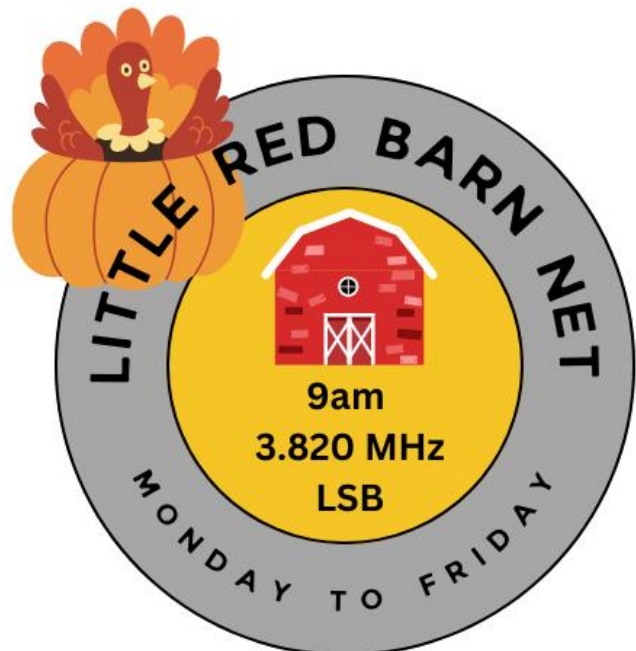


you need help.

THE OCTOBER 2024 STEW PERRY TOPBAND DISTANCE CHALLENGE

About a month ago, I decided to do some repair work on my 160m inverted-vee before the October Stew Perry contest.

Thanks to a pulley under a high limb of a big oak tree, the apex of the inverted-vee is at 55 feet. And with the pulley, it's easy to raise and lower the inverted-vee.

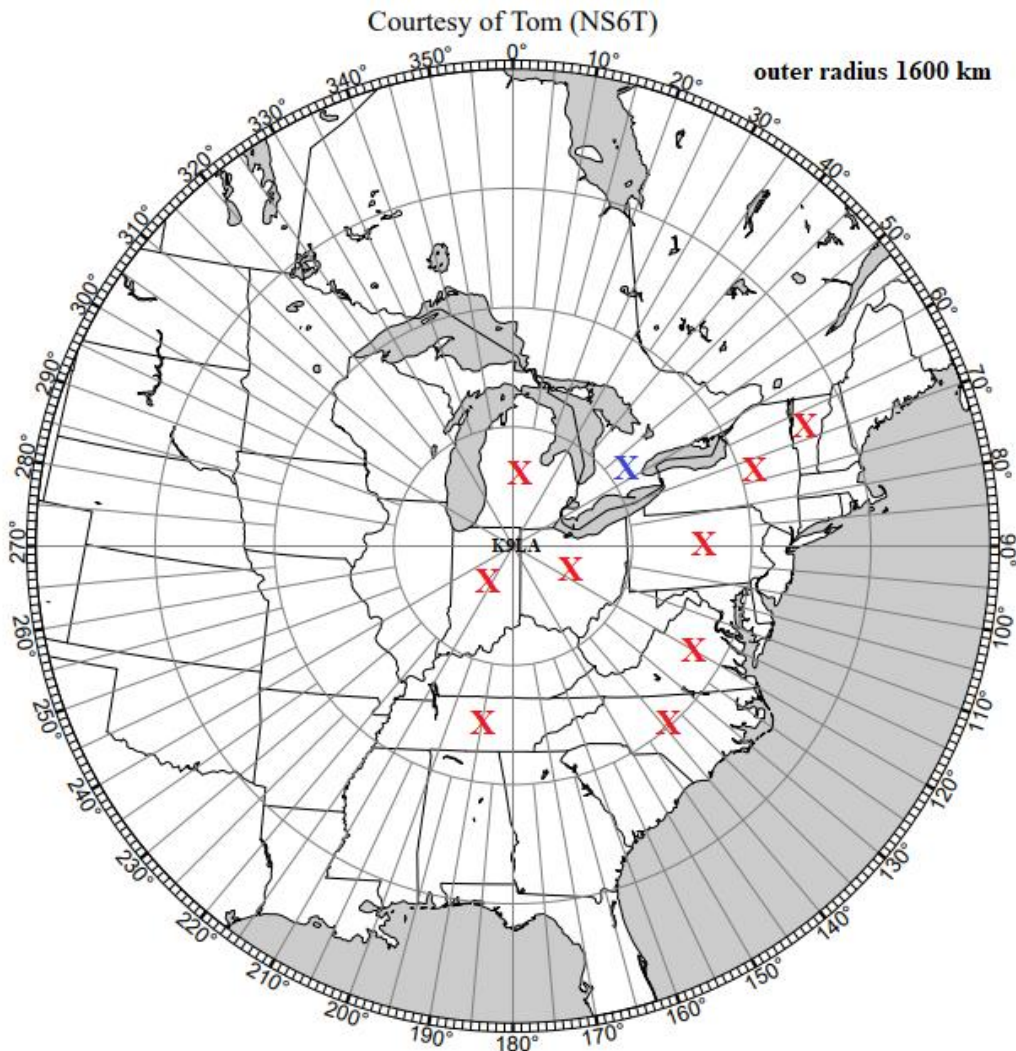
This antenna is not as good for DXing as my old inverted-L with elevated radials, but with 800 Watts I can work most anything I can hear on it. I may not be first (or twentieth) in the pileup, but usually I'll work the DX station.

While inspecting the inverted-vee, I noticed that the coax going up to the inverted-vee had some obvious problems. There were small cuts in the coax jacket and when I stripped back the jacket, the braid was not a shiny copper color – it was blackish, indicating water intrusion.

Replacing the old coax with new coax was easy. I then figured I should install new rope to haul up the inverted-vee center insulator. The old rope had some fraying (likely from squirrels). While replacing the old rope, I lost hold of the new rope and now I

have a pulley at 55 feet with no rope going through it.

I could hire a tree guy to walk up the tree and put new rope through the pulley, which would allow me to put the 160m inverted-vee back up. But then I started thinking of an alternate short-term 160m antenna for the October Stew Perry. My 40m inverted is at 45 feet on the east tower. The SWR of the 40m antenna itself would be extremely high when using it on 160m.



The SWR would be somewhat lower in the shack due to the loss in the 175 feet of RG-8 coax going from the shack to the 40m inverted-vee. The SWR measured around 15:1 in the shack per my Bird wattmeter and surprisingly, the tuner in my Ten-Tec OMNI 7 didn't have a problem with that SWR. Thus I was ready for the October Stew Perry contest – but with a compromise antenna. I did realize that I had two negative issues – I'd be a QRP entry due to the SWR and the October Stew Perry is one of the three mini-Stew Perry's with nowhere near the participation of the main December Stew Perry.

How did I do with 100 Watts to a 40m inverted-vee? I think I can truthfully say that my results were as expected from a station with a high SWR antenna. I worked 16 stations Friday evening and early Saturday morning. I snagged 9 states and Canada (Ontario). My farthest QSO was to Vermont at 1027 km (642 miles). Note on the map that I didn't work anyone to the west. I did hear K7RAT very weak in Oregon early Saturday morning, but I couldn't work him.

If a station was S6 or greater on my OMNI 7 S-meter, I had a good chance of working that station. Unfortu-

nately, there weren't many stations with a signal strength at or greater than S6. It's now obvious to me that I need to either resurrect my 160m inverted-vee or implement another good antenna for 160m because of the forthcoming ARRL 160m Contest (December 6-8) and the main Stew Perry (December 28). The bottom line is that I've made the decision to have fun with 800 Watts and a good antenna.

10 Meters is HOT!!!!

Its currently 1:30 in the afternoon on Thursday and here's what I'm hearing:

PA0FRX from the Netherlands, SP6IXF from Poland, and ZS6NL from South Africa on FT8 using 5 watts!! If you're wanting to work some new countries with a meager antenna, 10 is waiting for you! (Just a quick note: last weekend was the CQ World Wide SSB contest. I had over 700 contacts on 10 meters from 117 different countries!) CW ops: CQ WorldWide CW contest is the last full weekend of November on the 23rd and 24th. You don't have to be "in" the contest to participate. The contest exchange is signal report and CQ zone. We're in zone 4.

Another Update on the PFW Amateur Radio Station

Hello my fellow radio bugs! Welcome to the month of Thanksgiving and the Fort Wayne Hamfest. November is one of my favorite months for two reasons. First, we have Thanksgiving (who doesn't like turkey, stuffing, pumpkin pie, and a season of gratitude all thrown together!). Second, the Fort Wayne Hamfest is right 'round the corner.

The Fort Wayne Hamfest has always held a special place in my memory, because this was the first hamfest I ever came to as a ham radio operator (way back in 2014). Ever since then, I have tried to attend most every Fort Wayne Hamfest, both to relive old memories and to make new memories. This year will be no different, and if it is at all possible, I will enjoy connecting with you all at the hamfest, putting faces to callsigns, and sharing the excitement a ham gathering always brings!

Now for the main purpose of this article – an update on the PFW amateur radio station. As many of you know, I have spent the past year working with a mentoring professor to bring amateur radio back to the

PFW campus. This process actually began several years earlier when I had first arrived on campus. However, it wasn't until October of 2023 that I was able to begin taking preliminary steps to see if a ham radio station was possible. Thanks to the wonderful support of my mentoring professor, the school of engineering, and the PFW Honors Program, we are almost at our goal of installing the station.

Unfortunately, the task of installing the station is not as simple as could be hoped. Due to liability concerns, only particular individuals are allowed on the roof of the engineering building. This means that, to install the antennas for the station on the roof of the engineering building (where the ham radio station will be located), requires the services either of an individual from the on-campus staff or a third-party contractor. An on-campus staff member is apparently not available to assist with the station installation, requiring us to seek an alternate third-party to undertake the installation. Although a third-party contractor is available,

the cost to install the station is, quite literally, nearly equal to the cost of the station itself (including transceiver, power supply, coax cable, etc.) Ergo, we have been at an impasse for several weeks as various routes are tried to move the station installation forward.

What to do? As of yesterday, I believe there is a path forward that would both allow the station to be installed by the end of the year and would ensure the minimal cost is needed for installation. If this proposal proves acceptable, I believe that we could have the makings of one of the most unique amateur radio installations out of any university within the United States.

As of November 1, I am awaiting a response for this new proposal for the station. If accepted, I will begin the process to move the project forward in our new direction, with a full report occurring here in the December issue of the HamNews.

We'll see you in December!

Repeater Etiquette

Editor's note: This information is being included at the request of a local repeater trustee as a public service to the ham community.

The following information is a simple guide to courteous operation on repeaters. If you operate using these simple guidelines, you will make it more enjoyable for everyone operating on repeaters, and you will also set a good example for others. It never hurts to review the guidelines (and new hams may not be familiar with these guidelines) to make sure you are being a responsible amateur radio operator. Remember, repeaters are a public service, and general courtesy is expected of all amateur radio operators.

Take the time to listen to a repeater before you talk.

Transmit your call sign when you first come on the air. Make sure you ID once every 10 minutes, but there is no need to identify too often. (47CFR § 97.119.a)

Do not inject a comment into a conversation without saying your call sign. Part 97 of the Code of Federal Regulations, which governs our operations as amateur radio operators, requires that you identify with your callsign. (47 CFR § 97.119.a) Transmitting comments without identifying yourself is prohibited. Interrupting is no more polite on the radio than in the real

world

Do not monopolize the repeater. Simplex may be more appropriate for lengthy conversations. Keep in mind that repeaters are a shared resource and are to be available to a large community of users. A good operating practice is to use simplex for long conversations (rag chewing) if possible.

Our repeaters normally have a 3 minute "timeout" setting. The 3-minute length is meant as a maximum length, not a suggested length. It is considered good etiquette to keep your transmission length shorter than this.

Some topics are like land mines – Religion, Politics, Sex, etc. Do not discuss these subjects over the air! It can be more interesting than discussing what you ate for lunch last Wednesday, or the weather conditions you experienced two days ago, or how bad your bunions are troubling you, but "land mine" conversations can sometimes descend into a shouting match and can cause people to become upset (even those listening and not part of the conversation).

Do not belittle, berate, defame or speak ill of others.... period. This includes individuals, groups, nations, aspect of the hobby, etc. Using words such as idiot, stupid, hate monger, etc. in reference to any person, entity or group should not be tolerated.

Even 'mild' obscenities are not

good operating practice. This includes suggestive phrases, and suggestive phonetics. (47 CFR §97.113.a.4).

Give a pause before keying the mic and speaking. Don't start speaking as you key the mic. Repeaters have a short delay before transmitting. If you start speaking too soon, your first few words may not be heard. Make sure you have finished speaking before you unkey the mic.

Pause periodically to see if anyone else would either like to join the conversation or use the repeater for a quick call that is not part of the ongoing conversation.

When identifying, please say your call sign slowly and clearly. Call signs that are rattled off too fast can make the call sign totally unintelligible.

Don't forget that the FCC prohibits the transmission or retransmission of music (and almost anything else that is received over the airwaves; for specifics, see (47 CFR § 97.113.a.4). If you have a radio turned on (this is especially common for many mobile stations), make sure that it's turned down before you transmit.

When using "comment" or "break" to be recognized and you are acknowledged by net control or the folks using the frequency, then be sure to identify with your call sign.



From the FCC regulations

§97.119 Station identification.

(a) Each amateur station, except a space station or telecommand station, must transmit its assigned call sign on its transmitting channel at the end of each communication, and at least every 10 minutes during a communication, for the purpose of clearly making the source of the transmissions from the station known to those receiving the transmissions. No station may transmit unidentified communications or signals, or transmit as the station call sign, any call sign not authorized to the station.

(b) The call sign must be transmitted with an emission authorized for the transmitting channel in one of the following ways:

(1) By a CW emission. When keyed by an automatic device used only for identification, the speed must not exceed 20 words per minute;

(2) By a phone emission in the English language. Use of a phonetic alphabet as an aid for correct station identification is encouraged;

(3) By a RTTY emission using a specified digital code when all or part of the communications are transmitted by a RTTY or data emission;

(4) By an image emission conforming to the applicable transmission standards, either color or monochrome, of §73.682(a) of the FCC Rules when all or part of the communications are transmitted in the same image emission

(c) One or more indicators may be included with the call sign. Each indicator must be separated from the call sign by the slant mark (/) or

by any suitable word that denotes the slant mark. If an indicator is self-assigned, it must be included before, after, or both before and after, the call sign. No self-assigned indicator may conflict with any other indicator specified by the FCC Rules or with any prefix assigned to another country.

(d) When transmitting in conjunction with an event of special significance, a station may substitute for its assigned call sign a special event call sign as shown for that station for that period of time on the common data base coordinated, maintained and disseminated by the special event call sign data base coordinators. Additionally, the station must transmit its assigned call sign at least once per hour during such transmissions.

(e) When the operator license class held by the control operator exceeds that of the station license, an indicator consisting of the call sign assigned to the control operator's station must be included after the call sign.

(f) When the control operator is a person who is exercising the rights and privileges authorized by §97.9 (b) of this part, an indicator must be included after the call sign as follows:

(1) For a control operator who has requested a license modification from Novice Class to Technician Class: KT;

(2) For a control operator who has requested a license modification from Novice or Technician to General Class: AG;

(3) For a control operator who has requested a license modification from Novice, Technician, General, or Advanced Class to Amateur Ex-

tra Class: AE.

(g) When the station is transmitting under the authority of §97.107 of this part, an indicator consisting of the appropriate letter-numeral designating the station location must be included before the call sign that was issued to the station by the country granting the license. For an amateur service license granted by the Government of Canada, however, the indicator must be included after the call sign. At least once during each intercommunication, the identification announcement must include the geographical location as nearly as possible by city and state, commonwealth or possession.

A repeater trustee is responsible for the proper operation of their assigned repeaters. A repeater trustee is also responsible for:

- (a) Ensuring that the club station license is operated in the club's best interests
- (b) Following all FCC rules
- (c) Designating control operators
- (d) Determining who can use the club license

FORT WAYNE RADIO CLUB MEETING MINUTES

11 October 2024

The October meeting of the Ft. Wayne Radio Club was held on October 11th, 2024. It occurred at the Good Shepherd United Methodist Church starting at 6:31 pm. It was hosted by club President Adam Warrix, KD9NRT; there were about 23 attendees.

Adam led everyone in the Pledge of Allegiance and invited all present to introduce themselves with their name and call-sign.

Before the business meeting Adam introduced Dr. Jordan Marshall, NM9L, a professor of biology at PFW who presented a rather interesting description of Wild Life Telemetry techniques that are employed to determine the movements of small animals. The techniques are similar to Fox Hunting and utilize low cost equipment generally operating in the 150MHz range. Jordan and his compatriots have been published in QST and On-The-Air analyzing the effectiveness of low coat antennas, (tape measure, etc.) compared to commercially available antennas. They have also explored the employment of SDR techniques and hardware to visualize received signals (typically 20 millisecond pulses at 300 nanowatts) transmitted from subject animals displaying the received

signal on waterfall displays.

A very interesting presentation well received.

Bob Streeter, W8ST, provided the Treasurer's report dated 10 October, 2024 as follow:

Checking account balance is \$15,194.65 with a check for \$7,707.75 outstanding.

Savings account balance is \$10,504.33.

Vanguard Cash Reserves Fund balance is \$8,112.34.

Year-to-Date Operating Income is \$14,245.87

Year-to-Date Operating Expense is \$10,539.26.

Club Operating net gain / (loss) YTD = \$3,706.61

Current Club Account Liquid Assets, Year to Date = \$33,811.32

The estimated non-related interest/dividend yearly income now stands at \$988.00

The club income from the W9GT estate was \$2,507.25.

The club has 141 members for 2024.

The club has 3 members paid for 2025.

Al Burke reported that the roof of our building at Robison Park received a soluble rubber water proof coating last weekend thanks to the help of Kevin Emenhiser, N9KE, Clark Derbyshire, KG9FM and Steve Nardin, W9SAN. Hopefully we are protected from potential roof water leaks for the next four or five

years.

Al also reported that Clark Derbyshire inspected the wiring between the AEP energy meter and our service panel to see if any incoming power was diverted to other (unknown) loads, and not channeled through the service panel. Nothing was found. So the discrepancies between the energy consumption reported by AEP's meter and our instrumentation remain unexplained. The investigation continues.

The Board is recommending that the club make a donation of \$500.00 to the Red Cross Hurricane Relief fund in light of the two storms that recently plowed through the south-east. After some discussion amongst the membership it was decided that the donation be made to Samaritan's Purse which is currently focusing efforts for the victims of Hurricanes Helene and Milton. That recommendation was unanimously endorsed by all present at the meeting and the Treasurer will take action on the initiative.

Adam noted that the club had sold its two FT-1000 transceivers typically used at Field Day and other operating events, and the Board is recommending we purchase at least one new or used Icom IC-7300 as a replacement which will modernize our operating equipment. We are expecting that an IC-7300 can be had for \$1,000 to \$1,100.00 in today's market, perhaps less, if we were to run

into a vendor’s special promotion. So the proposal was made to authorize the Board to spend up to \$1,100.00 to acquire an IC-7300. It was seconded and put to a vote by the club members attending and the proposal was approved unanimously.

Steve Nardin noted that Tim Kearny of the Boy Scouts is suggesting that the Boy Scouts upcoming Jamboree On The Air (JOTA) that the club was looking at supporting might take place at the Scout offices of Jefferson Blvd. The club has supported activities from that site in the past but it suffers a high noise level due to the presence of high voltage transmission lines passing near the property. If the club supports the JOTA it needs a few more volunteers than have already volunteered to help (Steve Nardin, Jim Pliett, Al Burke and Terry Bowman). Steve Nardin will water-fall out a request for help.

Nominations for the offices of President, Vice President, Treasurer, Secretary, Communications Manager, Station Trustee and Newsletter Editor, and four Director positions were opened. At present the slate of those willing to run looks like the following:

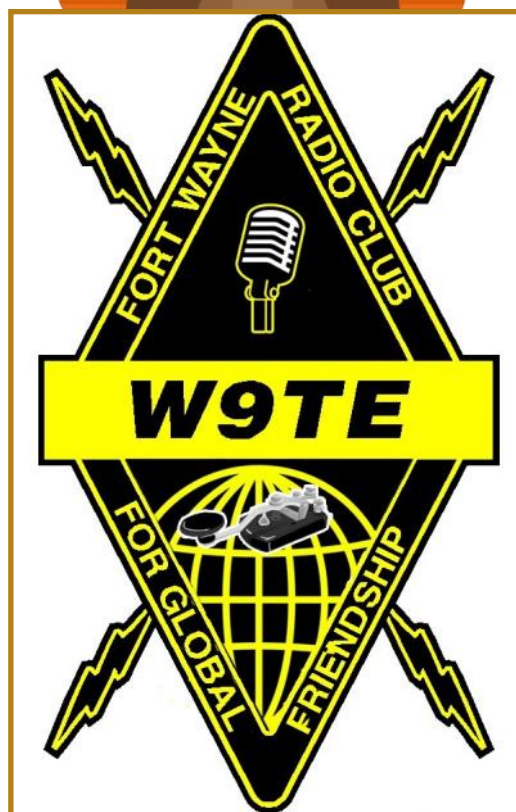
