Thank you all and see you in 2025!

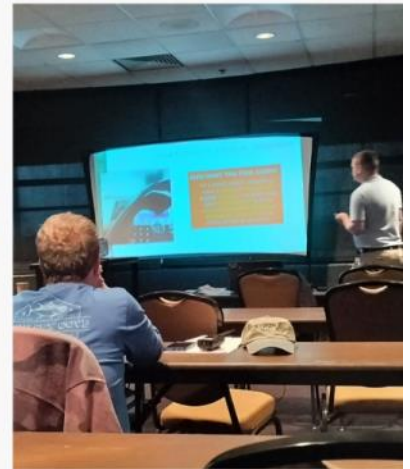

The 146.880 was  
 switched to PL

mode (141.3 Hz) on receive on Wednesday 11/27/24 afternoon because of errant noise problem on the input of 146.280 that morning. This caused the Repeater to time out many times and made the Repeater unusable. So the switch was made that afternoon during some scheduled work. We also eliminated the additional CW ID within the internal Motorola controller on the MTR3000, also installed a new Polyphaser lighting arrester and also installed the temporary UHF 443.800 Repeater so it's now back in service. Thanks goes to Stuart Hall KD9LFW and Kevin Hecksher W9KMH for helping me out.

It wasn't the way I wanted to go about it as far as the induction of PL on the receiver for .88 but the situation called for a guaranteed fix and immediate action. We will work on the flexible alternatives as we have time.

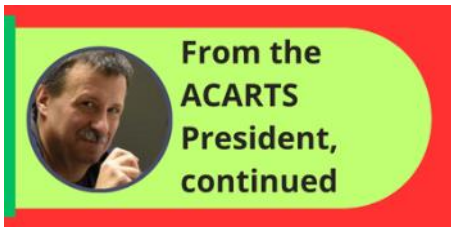

**ACARTS VHF PACKET RADIO SYSTEM**

The ACARTS W9INX VHF Packet System that was partially mentioned in the November issue of the ACHN had part of the article giving the perti-

nent information omitted.

It is running at my QTH low profile in Columbia City for the time being. Sometime after Thanksgiving and depending on scheduling with the IT Department it will then be installed within the City of Fort Wayne.

This will serve as a medium profile infrastructure to assist with 1200 Baud Winlink and Packet connections between stations on 145.530 MHz inside and outside of Allen County.

It is available for general and emergency use. This is a standalone remotely controlled station with no regularly manned terminal capabilities. Specifications follow:

We recently added another addition to the ACARTS fleet. It's a Bridgecom BCR-40U 40 watt UHF analog repeater and it had belonged to James Sampiere KD9NPL now SK and past ACARTS Station Manager as October 10, 2024.

Jim and I had discussed at least testing this one at WANE but it didn't ever come to fruition before he became ill. So now it will finally.

I considered in the beginning to look into the Bridgecom Repeaters but I was very leery because of the luck of some with the lower tier units. This is when while Jim and myself were shopping for replacements for our GE Mastr II repeaters that served us so well for 45 years. In the end so to be honest I was against anything but Motorola and Kenwood products. We still selected Kenwood as our two new replacements for the 146.88 and the 443.800 Repeaters. The 147.255 Repeater will receive the Motorola MTR3000 eventually.

It all depends on mostly selectivity, rejection of the unit itself, filtering, site location (noise floor) and dependability. but I think for the time being it will be fine to test it there and with our old tuned up Phelps Dodge UHF duplexer.

As with many repeaters it can be converted to digital use as well with the addition of MMDVM. For those familiar it can be by rights be programmed as a Community Repeater and to some extent it has been.

It will eventually serve dual duty one as a backup for the new arriving Kenwood 443.800 Repeater. But we also have other plans in the future for this one. Even at only 40 watts it should have good coverage at 575'.

## DXCC 2025 BY CARL LUETZELSCHWAB, K9LA

In the August 2023 column, I talked about the DX Advisory Committee (DXAC), and mentioned a need to review the DXCC rules and institute some new thinking into the DXCC program. At the Saturday evening FWDXA/SKCC dinner at the Ft Wayne Hamfest last month, Vicky and I sat at the table with several FWDXA members (NJ0U, W8UZ, NT9F) and a couple LDXA (Lafayette DX Association) members (N9FN, N9LF). Naturally, questions about DXCC came up.

It's been a quarter century since the last DXCC update by ARRL HQ, which was known as DXCC 2000. A major thrust was made to tighten up the rules on what makes an entity. Those rules have generally worked out well. But as the world has changed since then (in relation to the ability to activate an entity), maybe some rules need tweaking. Thus DXCC 2025 has been created.

It is the DXAC's responsibility to provide recommendations (hopefully of a unanimous or near unanimous nature) to the Programs and Services Committee (PSC) for changes. The PSC then votes to either approve the recommendations or sends the recommendations back to the DXAC for further work. If necessary, the Board can get involved, too.

DXCC 2025 has started with an initial Zoom meeting to set guidelines and generate a list of issues to address. This entire DXCC 2025 process will take at least several to a dozen meetings due to the nature of some issues and just the quantity of the issues that are planned to be looked at.

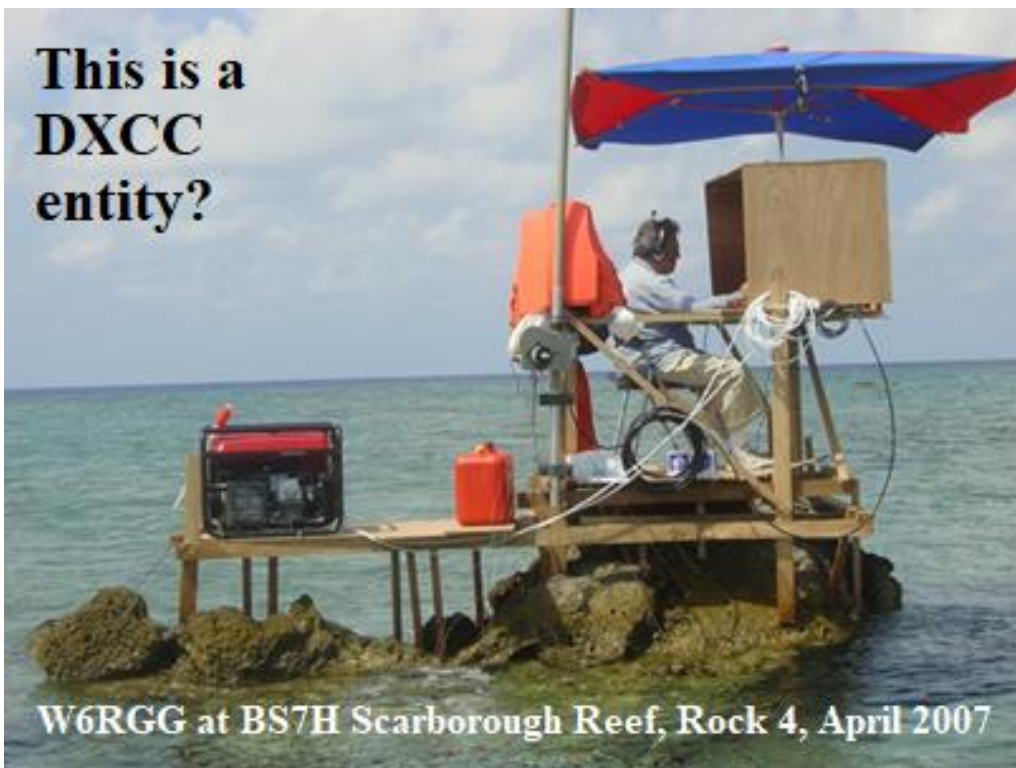
Issues to look at are (but not limited to) guidelines/rules for remote operation, getting more youth involved

in the DXCC program, adding 'inactive' in addition to the existing 'current' and 'deleted' categories, situations when robot QSOs could be allowed, adding more 'honor roll' levels, a new/additional DXCC program so newcomers could 'work them all', the 'boots on the ground' requirement (is there something 'close enough?') and island separation requirements.

Additionally, the ARRL DXCC List (January 2022) needs updating in the following areas: DX Advisory Committee Members, ARRL Incoming DX QSL Bureau Addresses, the ARRL Outgoing QSL Service, Countries Not Served by the Outgoing QSL Service, DXCC Item Order Form, DXCC Card Checkers and DX Entity Names. Although this is a job for HQ Staff, perhaps the DXAC could help out to ease the burden of recovering fully from the ransomware attack.

Being the Board Liaison for the DXAC, I have been directly involved with the DXAC issues since January 1, 2024. But since I didn't run for Director for 2025/2026/2027, I will not be involved. I will miss that, but c'est la vie.

## A Journey of a Thousand Miles Begins with ... Half a Step.

Hello my fellow radio bugs! Welcome to December and another issue of the Allen County HamNews. I hope everyone had a wonderful Thanksgiving celebration. It seems Thanksgiving is hardly over and it's time to prepare for Christmas.

As mentioned in last month's HamNews column, this month's column is an update on the PFW amateur radio station. The station has taken many twists and turns and has evolved into many forms. However, we are finally making some headway with a project installation of the first portion of the station completed by January of 2025.

As mentioned in last month's column, the main issue surrounding the installation of an amateur radio station at PFW revolves around access to the roof of the Engineering Building. The last amateur radio station at PFW had a multi-band vertical strategically placed in the center of the building with access to an awesome ground plane. This made the vertical a great-performing antenna, since the elevation of the vertical coupled with its good ground plane made for a very low-angle of radiation

with minimal obstructions to signals both coming from and received by the antenna.

However, when the proposal was made to install the new amateur radio station antennas on the roof of the Engineering building, some bad news was in store. Neither I nor my mentoring professor are allowed on the roof of Engineering to install the antenna due to liability concerns. Additionally, both I and my professor were told that there was apparently no one on campus that was part of university staff who were either allowed or comfortable with installing the amateur radio antennas. Thus, any option for installing the amateur radio antennas on the Engineering building would have to be done by a hired, third-party contractor. The estimated dollar amount for hiring a contractor to do the work of the installation would have met or even exceeded the total dollar value of the entire amateur radio station.

In the long-term, if policies and procedures continue as they currently stand, the station would become a financial and logistical headache to those students/professors/staff who maintain and operate the station. Any necessary antenna work required for maintaining the station would require funding to pay third-party contractors. Students would not be able to gain experience maintaining their own stations' antennas because they wouldn't be allowed on the roof.

If an antenna were damaged by inclement weather and the station were knocked off air, students might have to wait days or weeks before someone could be hired to fix the antennas.

Admittedly, the situation has become far more complex than what at first glance seems like a simple enough task. Because roof top access is simply not available, an alternative and creative solution is required to address the situation. I think that solution has been found.

The new PFW amateur radio station will be installed in two separate parts. On campus will be an hf station supplied mainly with equipment from the previous IPFW amateur radio station. Thanks to the efforts of Larry Temenoff, KB9OS, the old amateur radio station was, quite literally, saved from being thrown away in the nick of time. The old station had several hf transceivers, an amplifier, a tuner, and various pieces of equipment. For an antenna, the new hf station will use a commercial magnetic loop antenna, as these antennas are known to be effective for radio amateurs who are apartment dwellers or who need a portable antenna solution.





Although not the most efficient antenna, a magnetic loop can be installed within the new PFW amateur radio station without requiring payment for a third-party contractor to install the antenna.



Off campus, the Icom IC-9700 will be installed at a remote site, supplied with equipment already donated and purchased for the station. This off-site location will be able to be controlled via remote link (probably via the internet). Authorized students/professors/staff will be able to log in and control the station without needing to physically come on campus to operate the station.

The advantage of this multi-site solution is that students and users of the new amateur radio station will be able to experience a wide variety of operating scenarios and situations. The on-site hf station will give students the opportunity to service and maintenance their own antennas. The off-site location will give students experience in remotely controlling an amateur radio station. Since today's amateur radio world consists of both physically and remotely controlled stations (think of the "Radio in a Box" technology developed for dxpeditions' usage

on rare dx entities), students will give themselves valuable experience in owning, maintaining, and operating a multi-faceted station with physical and remote operating procedures.

The projected installation is set for January of 2025 for the hf station in the wireless communications lab, with rigs and equipment being gathered and tested throughout December 2024. The remote station installation will depend on when we can find a suitable remote site that will host the station. All equipment needed for the installation of both stations has now been gathered except for the magnetic loop, which should be purchased within the coming weeks.

It is hoped that this initial station will evolve into an ever more capable station with more offerings for the PFW community. With a strong connection to the local amateur radio community, PFW stands much to gain by increasing its amateur radio offerings. Although we have no guarantee for how long this new amateur radio station will last, it is hoped that this unique approach to amateur radio on a university campus will help ensure some kind of longevity for the station. Amateur radio is one of the best ways a person can educate themselves and experience the wonders and surprises of radio communication. By treating an amateur radio station as a teaching tool, similar to a lab or a musical instrument, we can demonstrate the value that ama-

teur radio brings to students of today and students of the future. Have a wonderful Christmas and a blessed 2025!

Stay tuned for the news of the new PFW amateur radio station in this column.
